Topic: 1
Micro Skill Drill Exam

Question: 1

A satellite broadband services provider is mobilizing a RISE with SAP program for SAP S/4HANA Cloud Private Edition. You are advising the transformation manager after the first scope governance review. Customer-contract scope decisions are documented in meeting minutes, network asset dependencies are tracked in a planning workspace, and Clean Core review items are captured in a separate architecture log. Several change requests already reference decisions that cannot be traced to the same readiness checkpoint.

The measurable constraint is that the sponsor must approve the next planning gate in six weeks, but the project team cannot replace its existing working documents because legal, finance, and operations teams are actively using them. The sponsor needs one evidence view showing whether scope decisions, open dependencies, change impacts, and governance topics support the same methodology checkpoint. The team is debating whether to continue manual reconciliation or align the current evidence to SAP Activate-aligned checkpoints with consistent references.

What is the best recommendation?

Question: 2

A regional toll-road operator is preparing a RISE with SAP transformation to SAP S/4HANA Cloud Private Edition. You are advising the executive sponsor during roadmap approval. The sponsor wants finance, maintenance purchasing, and concession revenue planning included in one accelerated plan because a new concession contract begins in six months.

The constraint is that the roadmap may run selected activities in parallel but must preserve phase accountability. The current plan marks several early outcomes as complete because named owners have accepted meeting invitations. The transformation manager is concerned that decision evidence, acceptance criteria, and readiness dependencies have not been confirmed before the team commits to implementation sequencing.

Which advisory response is most appropriate?

Billing, depot maintenance, and contractor management teams have submitted first-wave requests, but many items describe familiar local exception handling rather than future business outcomes.

The constraint is that the first wave must be scoped within six weeks and must protect service-charge transparency during the transition. Operations wants every local exception retained to avoid depot disruption, while finance wants stronger standardization before the roadmap is approved. The board needs a recommendation that turns the requirement list into a practical implementation sequence without carrying unnecessary legacy variation.

What is the best advisory response?

- A. Retain all depot and contractor exceptions in the first wave so operational teams can maintain familiar service handling during transition.

The operations team records berth-planning dependencies in a local tracker, finance records decision approvals in a shared workbook, and the transformation office tracks phase actions in a web-based project space.

The constraint is that the sponsor needs a reliable readiness view before approving the next planning gate, but the team has only four weeks and cannot replace all working documents. One proposal is to continue local tracking and request weekly status summaries. The measurable constraint is that planning may be compressed, but the sponsor must still show phase accountability before approving implementation sequencing. The current roadmap marks several early activities as complete because workshop materials were distributed and owners were assigned. The transformation manager is concerned that accepted outcomes, decision evidence, and readiness dependencies have not been confirmed, even though the sponsor wants to show rapid progress.

The measurable constraint is that the first release must be confirmed within eight weeks and must protect contract-margin visibility during the transition. Operations wants to include all mobile coordination workarounds because field supervisors rely on them. Finance supports standardization but is willing to accept temporary variation if margin reporting remains explainable. The board needs a recommendation that avoids both uncontrolled scope expansion and premature removal of business-critical behavior.

What is the best advisory response?

Response:

- A. Include all mobile coordination workarounds in the first release so field supervisors can maintain familiar execution practices while finance validates margin reporting later.
- B. Separate margin-critical outcomes from legacy workarounds and improvement ideas, map dependencies, and phase only justified temporary variations through Clean Core-aware planning.
- C. Prioritize finance standardization as the first-release anchor and move all operations-specific coordination requirements to a later wave after margin reporting stabilizes.
- D. Let each team classify its own items as mandatory, then use the combined mandatory list as the first-release scope baseline for board approval.

Customer operations wants to preserve the full exception pattern because disputed credits could delay service renewals. The architecture lead recommends removing all exceptions before the first wave to reduce lifecycle risk.

The measurable constraint is that active warranty-credit explanations must remain defensible for two transition cycles, but the target design must not carry unnecessary custom behavior. A third option is to retain only renewal-critical exceptions with business ownership, documented rationale, monitoring during the two cycles, and remediation timing. The steering group needs a recommendation that balances customer continuity, transition timing, Clean Core discipline, and long-term maintainability.

What is the best recommendation?

Response:

- A. Preserve the full warranty-credit exception pattern for two cycles so customer operations can avoid renewal disputes.
- B. Remove all fleet-customer warranty-credit exceptions before the first wave so the target design demonstrates maximum lifecycle discipline.

- C. Let customer operations approve retained exceptions and ask architecture to evaluate Clean Core impact after the second transition cycle.
- D. Retain only renewal-critical exceptions with ownership, rationale, cycle monitoring, and remediation timing to balance credit continuity with Clean Core governance.

Question: 11

CHALLENGE 1 — Cutover Readiness Across Laboratory Inventory Streams

Helixor's dashboard shows that inventory mapping setup is complete for the cutover rehearsal. During the advisory review, the methodology advisor finds that business validation evidence for several reagent categories is attached to a separate file and not linked to the rehearsal readiness view.

What is the best recommendation?
