The Classical period began with the death of Johann Sebastian Bach and ended in the 1820s. Franz Haydn was a major composer during this period. Imitative polyphony, in which voices sing the same text and the same

music, entering one after another, was a characteristic of Renaissance music.

Giacomo Puccini and Maurice Ravel wrote operas in the nineteenth century, but not as prolifically as Wagner and Verdi. Claudio Monteverdi and George Frideric Handel composed operas in the sixteenth and seventeenth centuries.
